# Where We're Going ... How We'll Get There ...

With all the changes going on at the state and national levels, including those at AAUW, it's time to reassess our direction—as women, as Montanans, and as AAUW members. This year's AAUW Montana convention will provide us that opportunity. We'll take stock and prepare to move forward in a positive way. And we'll have the Executive Director of AAUW, Linda Hallman, to help us do it.

Because the 24-hour format of our 2008 Convention in Billings was so popular, we are going to repeat it this year, except that we have shifted location to Lewistown, the geographical center of Montana. This way, no branch will have to face traveling "too far" to get there.

Realizing that the cost of lodging will be higher this year (because we won't be staying in dorms), the state board is offering a financial incentive to every branch that sends one or more delegates. If your branch sends one person to Convention, the branch will receive a check for \$75; if two show up, \$125; if three, \$175; and four or more, \$200. Each branch may decide how to distribute this money among their attendees.

In addition to the money paid directly to the branch, all state board members, including branch presidents, who attend the 10:00 a.m. Saturday board meeting (immediately prior to the opening of Convention) will receive mileage reimbursement for one car per branch (at 35 cents/mile) and a \$30 lodging allowance. These board reimbursements, when added to the \$75–\$200 branch incentive, should make attendance at Convention affordable to all.



#### President—Diane Ehernberger

Diane graduated from the University of Montana in Missoula with a B.A. in history and later returned for a secondary education certificate. She was a librarian at Bozeman High School for thirteen years until taking early retirement in 2006. A member of the Bozeman branch since 1992 and a paid life member of AAUW, she has served at the branch level as finance director, membership chair, book sale chair, and president. At the state level, she has previously served two terms as finance director, one term as membership VP, and is currently completing her first term as president. ## **AAUW Montana Makes It Happen**

AAUW's commitment to education, advocacy and research happens because AAUW members care enough to fund more than 250 fellowships, grants, and special awards. Montana branches have traditionally supported women's educational goals by sponsoring fellowships or grants that totaled \$476,302.69 as of January 31, 2010. Completing the funding of the Great Falls Centennial grant will carry Montana over the half-million dollar mark of named funding. In 2009, an additional \$1,100.00 was sent by Montana branches and members to the general AAUW Funds, which include the Educational Opportunities Fund, the Eleanor Roosevelt Fund, the Legal Advocacy Fund, the Public Policy Fund, and the Leadership Programs Fund. Also, \$495 was sent to LAF.

## The Business of Convention

#### **Proposed Resolutions**

To date, the state board has received four proposed resolutions, each urging action by AAUW MT members and branches during the next biennium. Because resolutions expire at the end of each biennium, they must be voted on at each convention if the proposed support or opposition is to continue. This year, delegates will vote on the following resolutions, as well as on any others proposed from the floor at the convention business session:

#### **Continuing Resolutions:**

- Support for continued funding of Indian Education for All
- Support, by both the branches and the state organization, of the Montana Women's Lobby

#### **New Resolutions:**

- Support for CI-100, which proposes a 36% cap on pay day loans in Montana
- Opposition to CI-102, which proposes extending constitutional rights to all persons from the moment of conception.



#### **Proposed Public Policy Program**

Before each convention, we take a close look at our current Public Policy Program (PPP) to see if any changes are warranted. Because the PPP forms the basis for all AAUW advocacy throughout the state, we must be sure that issues we expect to face during the coming biennium are addressed, at least in general terms. Otherwise, we have no foundation for our support for or opposition to legislation, initiatives, referendums or upcoming issues. Most of the additions proposed for the 2010-2012 PPP fall into those categories. The few that do not are being suggested because they either update the language to today's more common terminology or speak to an issue that is a federal, rather than a state, concern. Please read the INSERT to this newsletter to see all the proposed changes. Then come to convention to vote on them.

#### **Bylaws Discussion**

At the suggestion of Bylaws Chair Corky Bush, no bylaws changes will be brought before Convention this year. However, that doesn't mean that there are not bylaws issues to discuss.

AAUW made many changes to its organizational structure and bylaws last June at the 2009 Convention in St. Louis. In the Fall, the state and branches made mandated changes to their bylaws, but neither the state nor most branches made substantive changes to their respective bylaws at that time. Now it is time to start discussing the major decisions the state needs to make in its bylaws at our next Convention. Thus, instead of voting on written proposals, we will use the time reserved for Bylaws amendments to discuss the various options now available to our state organization.

#### **Convention Delegates**

Our state bylaws determines the status and number of state convention delegates as follows:

<u>Section 2. Voting Body</u>. The voting body of any AAUW-MT membership meeting shall be composed of:

- a. All elected and appointed officers of AAUW-MT,
- b. Chairs of all standing committees,
- c. Past Presidents of AAUW-MT who are members of the Association,
- d. Each  $\mbox{\bf Branch\ President}$  or an official representative of each Branch,
- e. One branch delegate for each ten (10) members\* or major fraction thereof, with additional representation of one delegate for every twenty-five (25) members, or major fraction thereof, above one hundred (100),
- f. One delegate, appointed by the President, for each ten (10) Statedues-paying members-at-large of the State, and
- g. One delegate for each  ${\bf college/university}\ {\bf membe}{\bf r}$  of AAUW-MT.

The table below gives the official February 1 count of branch membership and lists the corresponding number of branch delegates. Everyone, please fill in the appropriate delegate status on your registration form so there will be no delays at Convention.


