MONTANA WOMEN'S LOBBY

On November 20, 2014, the Board of Directors of the Montana Women's Lobby announced that they voted to disband, effective November 30. The main reason for this was the dwindling organizational and individual memberships and lack of funds to hire a half-time lobbyist for the 2015 legislative session.

The Board also decided that they would donate the remaining assets to *Montana Women Vote*, for the purpose of paying MWV dues for three MWL member organizations (AAUW-MT, Montana BPW and BPW-Bozeman. For more information, go to http://www.montanawomenvote.org.

LEGISLATIVE WEEKEND

On March 6 and 7, 2015, AAUW-Montana will gather for our biennial Legislative Weekend at the Capitol in Helena. At this time we are waiting for Montana Women Vote and the Women's Foundation of Montana to finalize their plans. Events will begin at 8:30 Friday morning with an issues briefing at the Montana Historical Society. At 10:00, we will cross the street to the Capitol for the rest of the day's activities. Several hot button issues: Early childhood education, Medicaid expansion, public funding of private schools, and LGTB anti-discrimination issues provide us with an opportunity to meet face to face with our representatives to discuss and promote our public policy issues. AAUW members will make their presence known by button-holing representatives, testifying before committees and attending hearings. In addition to providing input to our representatives, we have the opportunity to express our thanks to those who support our public policy issues. While at the Capitol we will be able to view the Women's History Mural, a dream turned into reality by Diane Sands and her team. Late afternoon and evening is the perfect time to reconnect with members from across the state and share our successes, challenges and hopes over dinner and perhaps a glass of wine.

After our busy Friday at the Capitol, Saturday's activities will be dedicated completely to AAUW. Claudia Richards, AAUW Staff member, is Jane of all trades at AAUW, having worked in Development for 13 years, Meetings for 3 years, and currently Senior Branch Relations Manager in Membership. She has visited 29 of the 50 contiguous states and can name at least one AAUW member in every US state and territory.
